WISEMANS FERRY CEMETERY CONDITIONS ATTACHED TO THE OWNERSHIP OF A NICHE SPACE

The Ownership of a space in the niche wall in the Cemetery confers the following rights and responsibilities on the owner:

RIGHTS

The exclusive right to the interment of an ashes casket in the reserved niche space and a plaque installed over the niche.

The right to have a bronze plaque fabricated with an inscription and fixed within the confines of the allotted niche space.

The right to transfer the ownership of the niche space to a transferee, successor, Power of Attorney, Executor, Funeral Director or competent person, provided that the transfer is registered with the Cemetery Authority.

RESPONSIBILITIES

Prior to the interment of ashes a written application must be made providing details for engraving of the niche plaque. The current fee must accompany the application which covers up to 6 lines of engraving with wording to be provided by the applicant.

The ashes need to be in the appropriate cylindrical container. These containers are available from Hornsby Council.

The owner of the niche wall space is responsible for the safe keeping of the Ownership Certificate.

The Owner is responsible for providing the Cemetery Authority with the inscription details for the preparation of the plaque.


NSW Public Health Regulations require the Cemetery Authority to make an entry in the Cemetery Register for statutory information about burials in plots only. However the Cemetery Authority is able to record information relating to the details on the plaque in the Cemetery Register.

The Owner of the niche space is responsible for the safe condition and upkeep of the plaque, provided that such maintenance does not cause any marking or damage to the surfaces of the niche wall.
