## **SUMMARY**

This report details the traffic implications of a proposed temporary 'Works Zone' in The Crescent, Cheltenham to accommodate construction during alterations and additions to **The Cheltenham Recreation Club** (60-74 The Crescent, Cheltenham).

## **SUBJECT**

Council has received a request for a temporary 'Works Zone' at the front boundary of 60-74 The Crescent, Cheltenham (The Cheltenham Recreation Club).

The building works project is in accordance with approved DA/975/2020.

(D08140307 - Notice of Determination - DA/975/2020 - 60-74 The Crescent, Cheltenham)

"Alterations and additions to recreation club and construction of an indoor Recreation Facility (Real Tennis)"

The initially proposed **12 lineal metres long** 'Works Zone' is required to accommodate deliveries and construction vehicles during construction which has commenced at the site and is required for a period of **11 weeks initially**.

Providing the temporary 'Works Zone' along the left-side site's frontage at The Crescent, Cheltenham will minimise disruption to traffic when construction vehicles require access to the site.

#### **CONSULTATION**

No further consultation is required as the location of the proposed 'Works Zone' is along the frontage of the construction site.
