REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of proposed signage and delineation installation in Victory Street near the intersections with Baldwin Avenue and Dudley Street, Asquith.

SUBJECT

Council has reviewed the existing traffic and parking conditions in Victory Street in conjunction with upcoming civil works.

Victory Street is a local road. Victory Street joins with Baldwin Avenue and Dudley Street to form two T-intersections at the north and south ends of the road, which are currently not signposted, and operate under the Australian Roads Rules.

The civil works project involves kerb and gutter construction, as well as some minor drainage works and pavement reconstruction. The works are anticipated to take approximately 12 to 14 weeks dependent on the weather.

The proposed concurrent traffic and parking improvements consist of:

1. Formalising the two T-intersections with "Give Way" signs and "Give Way" delineation.
2. Installation of double barrier lines in Victory Street on the approaches to Baldwin Avenue and Dudley Street.
3. Installation of "No Stopping" restrictions in Victory Street near both intersections.
4. Adjustment to the alignment of 40km/h school zone and dragon's teeth pavement markings on Victory Street on the approaches to Baldwin Avenue and Dudley Street.

CONSULTATION

Public Consultation was performed by Council's Design & Construction Branch in July 2024.

Residents of Victory Street were notified by letter about upcoming civil works - "Proposed Road Reconstruction - Victory Street, Asquith".

The proposed works, listed in Council's Local Roads Improvement Program, were also exhibited on Council's Your Say Hornsby website.

Further consultation is not warranted as the proposed signage and delineation will formalise the existing road rules that apply to an intersection.

 3. Installation of double barrier lines in Victory Street on the approaches to Baldwin Avenue and Dudley Street be approved.
 4. Adjustment to the 40km/h school zone and dragon's teeth pavement markings on Victory Street on the approaches to Baldwin Avenue and Dudley Street be considered by TfNSW.
