REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of the Proposed Installation of Two New Bus Zones, south of Phyllis Avenue, at the request of CDC NSW Bus Company, to provide bus services to the surrounding commercial premises in Thornleigh.

SUBJECT

Hornsby Council has received a request from CDC NSW Bus Company to install two new Bus Zones in Central Avenue, Thornleigh.

In response to ongoing requests by residents, and staff employed in the surrounding commercial premises in Thornleigh, CDC NSW Bus Company proposes to install two new Bus Zones to accommodate the rising demand from employees commuting to and from their place of employment.

Proposed Bus Zone on the **western** side of Central Avenue would retain 10 metres of the existing "No Stopping" zone in front of 21-31 Central Avenue, and convert the remaining 14 metres as the new Bus Zone.

Proposed Bus Zone on the **eastern** side of Central Avenue is located between the "McDonald's" exit driveway, along the landscaped area, until the "Loading Dock Entry Only" driveway to the next property (2-10 Central Avenue) 20 metres. **This would result in a total loss of three unrestricted on-street parking spaces. (see Attachment 4)**

The hours of operation of the proposed Bus Zones are "6:30am - 8pm, Mon - Sat" which aligns with the existing Bus Zone on Bellevue Street.

It is noted that the proposed length of the Bus Zones is less than the recommended 30m. This is considered acceptable as "No Stopping" restrictions and driveways are located immediately on the approach to, and departure from, the proposed Bus Zones, which will allow buses to pull in to, and depart safely from, the zones.

CONSULTATION

CDC NSW Bus Company conducted Community Consultation with nearby residents and employees 27 May to 10 June 2024. The community was provided with at least 14 calendar days to respond. No submissions or objections were received.

RECOMMENDATION THAT

- 1. Installation of a new 14m long "Bus Zone 6:30am 8pm, Mon Sat" on the **western** side of Central Avenue approximately 10 metres north of the pedestrian crossing be approved in accordance with plan No LTC 23/2024.
- Installation of a new 20m long "Bus Zone 6:30am 8pm, Mon Sat" on the eastern side of Central Avenue, south of "McDonald's" carpark driveway in Central Avenue be approved in accordance with plan No LTC 23/2024.
