

INTRODUCTION

Council prepared exhibition documentation for proposals to introduce traffic-calming measures and amend parking arrangements in the main street, and upgrade paths, roadside verges, and the corner park in Galston Village.

The works seek to enable upgrades that account for higher level of use due to population growth, and deliver facilities, amenity and environmental improvement. Specifically, the work proposes to deliver:

- Revised parking arrangements
- Traffic-calming measures
- Footpath and safe crossing improvements
- Enhanced water sensitive urban design (WSUD) drainage systems
- Street tree planting and landscape works
- Improved public spaces for leisure and recreation

The Public Domain Plan was exhibited from April 29 to June 2, 2024 via Dropin Sessions, Council's Have Your Say webpage and briefing to Arcadia Galston Residents Association (AGRA).

Notification of the exhibition and invitation to make submissions were provided via signage and flyer distribution in Galston Village, supported by email newsletter, social media and local newspaper advertisement.

As a result of the exhibition and engagement, valuable input was received, which will inform the next phase of design development towards construction.







SUMMARY OF OUTCOMES

During the engagement period, 68 submissions were received, with around 100 people attending the Drop-In sessions, and approximately 60 people attending the AGRA Briefing.

In general, strong support was received for the proposals involving trafficcalming measures, improved pedestrian safety, wider paths and greater accessibility for the elderly or those with mobility issues. Strong support was also received for more planting and shade cover, and improved public spaces for leisure and recreation.

From the total of (68) submissions received, forty-six (46) submissions were generally in favour and expressed the need for upgrades, twenty-one (21) expressed neither support or opposition but provided suggestions or raised concerns about aspects of proposals, and one (1) submission disagreed that any upgrade was required at all.

KEY THEMES

This section summarises the key findings and narratives that emerged from the online survey, community Drop-In Sessions and the AGRA Meeting.

Village character

Preserving and enhancing village character was one of the topics raised in many submissions and in the AGRA briefing.

The residents of Galston stress the importance of outcomes remaining rural and distinctive from urban areas.

Vehicle speed and crossings

There is widespread support for a Speed Zone Reduction being adopted in Galston Village and many provided support for all traffic and parking proposals.

While it is broadly acknowledged that the existing setting is dangerous for vehicles and pedestrians, for those commenting directly on the topic of

crossings, twenty-three (23) directly expressed favour for the introduction of pedestrian crossings with eight (8) expressing opposition to any crossings. There were also differing views about crossings being raised or not raised. Fifteen (15) of the affirmative submissions support crossings being raised and four (4) support crossings but not raised. Another four (4) query the number of crossings required.

The Glen Street 'rat run'

Concerns were raised that more traffic will elect to take a diversion through two local streets, Glen Street and The Glade, in order to bypass the shopping area.

The issue was raised at Drop-In Sessions and seven (7) online submissions were received in relation to this issue. It is noted that use of Glen Street as a 'rat run' is an existing issue, where concerns are that this may worsen as a result of proposed changes. Concerns were also raised about the speed of vehicles entering Glen Street and pedestrian crossing safety.

Parking at the shops:

While many submissions support all traffic and parking proposals, differing opinions were provided about a median being incorporated and changes to parking immediately in front of the shops on Galston Road.

Twenty-four (24) submissions supported the angled parking and median, believing it would improve safety for all shop visitors with seven (7) opposed.

Some expressed concerns that angled parking is unsafe or that preventing car access from the east is unfair, would worsen the issue with Glen St being used as a 'rat run' and that parking numbers should not be compromised in this location.

Other submissions provided recommendations such as keeping the 90-degree parking, extending angled parking to the south side of the road, remove angled parking altogether, and changing parking to 'reverse-in'.

Access to toilet facilities

Availability and access to wheelchair accessible public toilet facilities within Galston Village was raised through several online submissions, during the Drop-In Sessions and at the briefing with AGRA.

Twenty-one (21) submissions expressed concerns with the lack of availability to accessible toilet facilities located with the Aldi Village marketplace. The Council facilities at the Galston Library are considered by many to be inconvenient in their location, away from the shops.

It is noted that management practices have changed for existing accessible facilities located within the Aldi Village Marketplace. The facilities have been managed for restricted access for the last 10 years but are now open for access daily. An understanding of this recent change is not reflected in a number of submissions.

Planting species and maintenance

The choice of tree and planting species and concerns with ongoing maintenance were mentioned in several submissions and during discussions at Drop-In Sessions and the Briefing with AGRA.

There are differing opinions regarding the preference for native or deciduous tree species.

Concerns about future maintenance were raised by a few residents. Some suggested that council have a long-term maintenance plan for any works proposed in Galston. AGRA group also offered to organise community volunteers to assist in maintaining the street gardens.

Other community concerns

In addition to key themes, submissions raised specific issues such as increasing parking availability, ensuring planting does not obstruct views or impact on bin servicing, reconsider playground location, retaining the village carpark slip lane, providing facilities for horse riders, and upgrading lighting.

NB: Plans will be refined in response to the exhibition and through detailed design development, including for all components illustrated in the draft Public Domain Plan.

PROGRAM

Following the broad Community Engagement, Council will collaborate with consultants to refine the design and prepare construction documentation for Tender. Construction is expected to commence in 2025 for completion in the first half of 2026.

Updates on progress and amended plans will be exhibited on the Council webpage, providing opportunity for further comment as the project progresses.

FINANCIAL PLAN

Council's Delivery Program 2022-26 identifies a need for the creation of vibrant town centres in Hornsby Shire, with Galston identified for

improvements in 2025/26 to support the local economy and encourage visitation to the Shire.

The project is identified in Council's Long-Term Financial Plan (LTFP) with capital works and general funding being provided to see the project through to completion.

TfNSW APPROVAL

As Galston Road is a State Road, Transport for New South Wales (TfNSW) approval is required. Council will obtain a Road and Safety Audit (RSA) to provide recommendations for achieving compliance with guidelines and Australian Standards before submission to TfNSW for approval.

NEXT STEPS

The exhibition for receiving of submissions was closed on Sunday, 02 June 2024. Outcomes of the Community Engagement process will be considered in the refinement of the concept design.

Meetings with landowners will be undertaken regarding proposals tabled in the draft PDP which involve works on privately-owned property. Additional engagement will be undertaken with key stakeholders.

Through design development and detailed design phases, aspects of draft PDP proposals will be refined. This will include roadway elements and spatial design for the park, plus detailed planning for planting, furniture and other elements to be realised within the public domain.

The plans will be subject to a Road Safety Audit to assess proposed parking changes and traffic-calming measures including median and crossing proposals for compliance with Australian Standards. Subsequently, the plan will be submitted for Approval by Transport for New South Wales (TfNSW).

Summary of Submissions are provided in the table below.

Summary of comments received

| 1 | With all the retirement developments being constructed around Galston at with moment this looks like a very good idea . |
