REFERRAL OF TRAFFIC MATTER FOR COMMENT OR OBJECTION, IF ANY

SUMMARY

This report details the traffic implications of the installation of two proposed 'Bus Zones' and installation of proposed 'No Stopping' restrictions in John Road, Cherrybrook, near Golden Grove, to reinforce NSW Road Rules and to address the regular occurrence of illegal parking.

SUBJECT

Council has received requests from local residents of John Road and Golden Grove, concerning illegal parking occurring at nearby Bus Stops, and near the intersection of John Road and Golden Grove.

The affected Bus Stops are:

Bus Stop ID 2126-23 - 1 Foxwood Way (John Road frontage)

Bus Stop ID 2126-36 - 31 John Road

Bus Drivers are experiencing difficulties with passenger set-down and pick-up, due to cars parked at the Bus Stops. The Bus Stops are used 7 days a week, by Bus Routes 626 and 635. Monitoring of the location shows that cars are frequently parked inappropriately.

To address the issue, it is proposed to regulate the Bus Stops by installation of two 'Bus Zones' in John Road, and by installation of 'No Stopping' restrictions at the intersection of John Road and Golden Grove.

The detail of the proposed signs is shown on attached drawing LTC 36/2024.

CONSULTATION

There will be no loss of on-street parking at the locations as the NSW Road Rules prohibit parking at Bus Stops and near intersections. Consultation is considered not necessary as the proposal is simply reinforcing the road rules.

Nearby residents and occupiers will be notified of the approval before installation.

Bus Stop ID 2126-36 - 31 John Road
 2. Installation of 'No Stopping' signs in John Road, at the intersection with Golden Grove, Cherrybrook, be approved in accordance with Plan No LTC 36/2024.
 3. Nearby residents and occupiers be notified of the approval before installation.
